Shri P. Manna – In the Chair

1. Financial Bids in respect of both the Packages viz. 1/2 and 2/2 were decrypted one by one. Bidders present were given the opportunity of viewing the Financial Bid opening through projection in real time.
2. Financial Bids for Package -1/2 was opened first in terms of ITB 35.1. Rates quoted by the bidders were as follows: -

3. Financial Bids for Package- 2/2 was opened thereafter. Rates quoted by the bidders were as follows: -

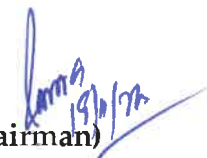

4. The rate of Rs. 4099.10 offered by Avon Cycles Ltd. was found to be the lowest Financial Bid offered and hence declared as the single lowest Financial bid across both the packages. Avon Cycles Ltd. was found to be the L1 bidder for Package- 1/2 and therefore, was declared as the Selected Bidder for the said package.



5. In Package-2/2, Hero Cycles Ltd. was found to be the L1 bidder with a Financial Bid of Rs. 4105/- & therefore in terms of ITB 35.1, Hero Cycles Ltd. was offered to match the L1 rate of Rs. 4099.10 being the lowest rate among both the packages. Hero Cycles Ltd. agreed to such proposal.
6. System generated BOQ chart (comparative statement of rates) in respect of both the packages were signed by the bidders as well as by the members of the Tender Committee.
7. Thus, Package-1/2 was awarded to Avon Cycles Ltd. and Package-2/2 was awarded to Hero Cycles Ltd.
8. The meeting ended with vote of thanks to and from the Chair.
