Shri P. Manna – In the Chair

1. Financial Bids in respect of the Packages viz. 1/3, 2/3 and 3/3 were decrypted one by one. Bidders present were given the opportunity of viewing the Financial Bid opening through projection in real time.
2. Financial Bids for Package-1/3 was opened first in terms of ITB 35.1. Rates quoted by the bidders were as follows: -

3. Financial Bids for Package-2/3 was opened thereafter. Rates quoted by the bidders were as follows: -

4. Financial Bids for Package-3/3 was opened thereafter. Rates quoted by the bidders were as follows: -

Avon Cycles Ltd.	8,408/-	4,204/-	L2

5. The rate of Rs. 4,194/- offered by Hero Ecotech Ltd. in Package-1/3 was found to be the lowest Financial Bid offered across all the 3 Packages and hence declared to be the L1 rate. Hero Ecotech Ltd. was found to be the L1 bidder for Package 1/3 and thus was declared as the Selected Bidder for the said package.
6. In Package 2/3, in terms of ITB 35.1, Avon Cycles Ltd. is the L1 bidder with a Financial Bid of Rs. 4,204/-, and they were offered to match the L1 rate of Rs. 4,194/- for Package 2/3 to which they agreed. Thus, Avon Cycles Ltd. was declared as the Selected Bidder for the said package.
7. In Package 3/3, in terms of ITB 35.1, Hero Cycles Ltd. was the L1 bidder with a Financial Bid of Rs. 4,197/-, and they were offered to match the L1 rate of Rs. 4,194/- for Package 3/3 to which they agreed. Thus, Hero Cycles Ltd. was declared as the Selected Bidder for the said package.
8. System generated BOQ chart (comparative statement of rates) in respect of all the three packages were signed by the bidders as well as by the members of the Tender Committee.
9. Thus, Package 1/3 was awarded to Hero Ecotech Ltd., Package 2/3 was awarded to Avon Cycles Ltd. and Package 3/3 was awarded to Hero Cycles Ltd.
10. Considering the quantum of procurement, the tender committee unanimously resolved that prior to issue of work order in favour of Hero Ecotech Ltd, Avon Cycles Ltd. & Hero Cycles Ltd. for packages 1/3, 2/3 & 3/3 respectively, concurrence of Finance Department may be sought through Administrative Department.
11. The meeting ended with a vote of thanks to and from the Chair.
